

# IP Justification Form



DomainGurus, Inc. (hereafter referred to as "DomainGurus") conforms to the North American IP Registry (ARIN) policies regarding IP address assignment. As part of our standard service, DomainGurus will assign the amount of IP addresses that clients can justify for use on their own and their client's equipment. Use this form for initial assignments as well as any additional IP addresses requested. We require a written justification form for any IP address blocks requested so that we can demonstrate to ARIN that IP addresses allocated to DomainGurus are being used efficiently.

Per ARIN guidelines (<http://www.arin.net/policy/index.html>), organizations will be assigned address space based on immediate utilization plus a six month and twelve month projected utilization. Organizations must exhibit a high confidence level in their six month and twelve month utilization rate and supply documentation to justify the level of confidence. DomainGurus will not generally assign IP blocks greater than /24 (class-c) to new clients. If a new client is transferring their service from another provider, DomainGurus will assign a block greater than or equal to their existing assignment provided that the below holds true for their existing assignment.

Existing clients must have efficiently utilized all previous assignments and at least 80% of their most recent assignment in order to receive additional space. This includes all space in use by their Clients. Please note that until your prior utilization is verified to meet the 80% requirement, DomainGurus can neither process nor approve a request for additional addresses.

Utilization rate of address space is a key factor in justifying a new assignment of IP address space. Requesters must show exactly how previous address assignments have been utilized and must provide appropriate details to verify their one-year growth projection. The minimum criteria that must be met are:

- A 25% immediate utilization rate, and
- A 50% utilization rate within one year.

If the client does not meet the minimum criteria, DomainGurus reserves the right to revoke the assignment and reassign an appropriate number of IP addresses. \_\_\_\_\_ Initial
